#### **NEWSLETTER FOR AUGUST 2016**

THIS NEWSLETTER AHEAD OF THE QGM IS BEING ISSUED LATER THAN USUAL AS WE WISHED TO INCLUDE THE LATEST INFORMATION ON THE LOCAL ELECTIONS AND THE MAIN ROAD REHABILITATION PROJECT.

#### **OUR COUNCILLORS**

We welcome our Ward Councillors elected at the Local Elections on 3 August.

#### **Felicity Purchase**

Felicity, a B.Com graduate, is the elected councillor for Ward 69 which includes the <u>FHVRRA</u> areas of Sun Valley and Stonehaven. Other areas are Sunnydale, Masiphumelele, Noordhoek and Glencairn.

We all know Felicity who has an illustrious career with highlights inter-alia being:

- Ward councilor for Fish Hook from 1995
- Chairperson of South Peninsula Subcouncil (Subcouncil 19) (2011 to date)
- Mayoral Committee Member for Economic Development and Tourism, City of Cape Town (2009 to 2011)
- Member of Tourism, Events and Marketing Portfolio Committee, City of Cape Town (2009 to date)
- Deputy Mayor of South Peninsula (2000 to 2006)
- Member of various boards and trusts of Charities and NGO's
- Member of Portfolio Committees of Transport, Roads and Stormwater, Finance and Utility Services of City of Cape Town
- Board member of Fish Hoek Chamber of Business for 30 years
- Representative of the City of Cape Town at a number of International Fora

#### Aimée Kuhl

Aimée is the elected councillor for Ward 64, taking over from Dave D'Alton who has retired. Ward 64 includes the FHVRRA areas of Clovelly and Fish Hoek (except Sun Valley and Stonehaven). This ward includes Kalk Bay, St James, Muizenberg and Lakeside.

Aimée studied Socio-Economic development at UCT. Thereafter she worked in the NGO sector iro community development and as a consultant in Public Works – in particular as regards needs assessment. She joined the DA two years ago working in various support roles.

At a recent Exco meeting she indicated that she believes that as a councillor she will be able to facilitate change and bring communities together.

#### REHABILITATION OF MAIN ROAD BETWEEN MUIZENBERG AND CLOVELLY

Here below is the report received from the contractors on 10 August.

"The third and final phase of our current assignment for the rehabilitation of 4.5 kilometres of Main Road is approaching the final stage. Construction of this phase began in March 2014 and is scheduled for completion in October 2017. We are currently nearing completion of the penultimate stage. The work includes the replacement of all underground municipal services including a 700 mm diameter bulk water supply main feeding the reservoirs in the southern peninsula. The water main is now complete and functioning.

The work also includes the replacement of the sewers, stormwater drainage, water reticulation and property connections, electrical cables and telecommunications infrastructure. Throughout the construction process the existing municipal services must remain operational and be finally removed on completion of the new service. The ongoing design challenge is finding sufficient space within the narrow half-width corridor to accommodate the new infrastructure.

Construction is carried out in half road widths and currently 13000 vehicles per day are accommodated using a twenty four hour stop go system. (+/- 6000 vehicles per day have migrated to other routes or modes). The project also includes the construction of a new retaining wall up to 6m high and 500m long separating the road and rail reserve".

#### **SEWERAGE & STORMWATER SYSTEMS**

Exco member **Helen O'Regan** keeps a watchful eye on sea water quality and other water issues. She writes:

"Fish Hoek's sewerage system commenced operation in 1939. The population then was tiny. The pipes installed then were of relatively small diameter and now they are very old.

During the last several years whilst Municipal officials do their best to keep it operating efficiently, there have been breakdowns, blockages and backing up of waste water which has unpleasantly erupted through inspection manholes in undesirable places. We can all help municipal workers in their endeavours by ensuring that ABSOLUTELY NO foreign matter like cleaning cloths and poisonous fluids are allowed in our waste water system. No storm water should be routed into the drains. Please check that the rain water falling on your roof is not being routed into your waste water system to increase the volume.

Please speak to your friends and relatives asking them to do the same so that the volume of waste water routing through the system does not increase to breakdown point when we are blessed with rain.

Municipal money will not be easily diverted to replace or upgrade our system. Those monies are being utilized elsewhere where there presently are not even rudimentary waste water systems, so we in the Fish Hoek Valley have to do our best to keep this present system operating as trouble-free as would be possible with everyone's co-operation.

The Municipal Laboratory reports that Fish Hoek's sea water quality has maintained a steady level of non-compliance. Individual readings indicate acceptability, but overall the 90th percentile readings for e-coli and enterococci do not make us proud.

Our storm water run-off also, is being consistently polluted to unacceptable levels. Crossing Fish Hoek's beach we have two storm water run-off culverts which are OFTEN polluted by sewerage. This is unhygienic and avoidable. People paddle through that water. Children play in it, oblivious of the pollution levels. If you are aware of anything like dirty bins being cleaned and drained into the storm water system or of sewerage being channelled into the storm water system; of any other pollutant entering the street gutters and thereby ending up in this urban run-off crossing our beach, then please become civic-minded.

Please let us know if you are aware of any way in which the quality of our Urban run-off water could be improved by changing our habits and the habits of those living around us".

#### **BEACH AND JAGER WALK**

**Lorraine Lemmon-Warde** who keeps a watchful eye on the beach and its environs writes:

"It is disappointing to note the lack of maintenance and improvements for this past year. It is hoped that a change in management, which is in progress, will change this situation. The beach continues to draw crowds on weekends and holidays, even during winter.

Unfortunately we have so far been unsuccessful in getting permission to collect the beach parking funds for more dedicated use of the Fish Hoek Beach.

There has been discussion about removing the bathing boxes from the beach as they have become a refuge for vagrants and other undesirable characters. From the original three or more rows of colourful little huts now only seven remain. The FHVRRA feels that they add character to the otherwise boring beachfront and that a solution should be found with better beach management and security".

The beach and Jager Walk are the prime attractions of Fish Hoek. Exco member **Rob Downey** has undertaken to establish a "**Friends of Fish Hoek Beach**".

#### **TOURISM**

Exco member Alan Lindner who promotes Fish Hoek as a tourist venue writes:

"South African Tourism recently announced its aim to increase the number of travellers to and in South Africa by five million in the next five years. The aim would be for four million of those travellers to be internationals and the remaining one million to be from the domestic market. As per Cllr. Simon Liell-Cock, tourism must be a main focus in the Far South Peninsula. Tourism is generated by three main attractions: Cape Point, the penguins and Table Mountain – not by the Waterfront. The Far South Peninsula needs to promote overnight stays, not one day visits by coach".
